



**CYSL Nado Select  
Financial Assistance (FA) Program  
2011-2012**

CYSL recognizes that some players may be limited in their ability to meet the financial obligation required to participate in competitive soccer, and therefore has created a financial assistance (FA) program. This program was designed to provide a limited number of Select players (U11 and above only) an opportunity to offset their financial obligation by providing services to CYSL.

FA recipients and/or their parents /relatives/donors can provide CYSL authorized services to and for CYSL that CYSL will credit toward the players' fees at an agreed upon hourly service or pay rate for a specific service, e.g., refereeing, field marshaling at CYSL sponsored tournaments, CYSL sponsored maintenance. The money they earn by performing the services will be credited toward their CYSL fees and in addition to this, CYSL will match these credits 100% up to a maximum of \$350 for the season. For example, FA recipients earn \$50 doing an authorized CYSL function/project for CYSL; CYSL will in turn match this \$50, resulting in a \$100 credit toward the player's fees. The maximum credit CYSL will donate toward a single player is \$350. After this maximum has been reached, players may continue to provide authorized services at the established rate, but their earnings will no longer be matched by CYSL.

All fees earned through services provided to CYSL will continue to be credited toward the player fees until the fees are paid in full. FA recipients will be given a list of administrators/assignors for each service. It will be the responsibility of the player/family member/donor to contact the designated administrator/ assignor-to sign up for specific services/projects. (For example, Manny Neves must be contacted for Spring Rec Referees and for maintenance projects; Terry Bucklew must be contacted for Fall Rec and youngers' Select Referees.) Failure to show up for an assigned service/project without 24 hour notice may result in the player not being given additional opportunities to earn fees.

Also, FA recipients must abide by their respective signed payment plan schedule to benefit from this FA program. It is the FA player/family member/donor's responsibility to contact the CYSL bookkeeper/administrator ahead of due date if payment plan issues arise. This plan applies for FA participants for the 2011-2012 season.

If an FA recipient chooses to leave the club before the season has concluded, then the recipient forfeits all CYSL matching donations and is responsible to pay CYSL and team fees in full in order

to request a transfer. Additionally, CYSL reserves the right to terminate a FA agreement if the recipient fails to meet program requirements. In such cases, the FA recipient/family member/donor may request a meeting with the FA Committee of the CYSL Board to review the respective case.

FA funds are limited; for this reason, all requests should be submitted no later than June 5, 2011. Late applicants will be put on a waiting list as of the date the FA application is received and, depending on funds allocated to the FA program, they may or may not be granted access to the FA program.

A small committee of CYSL Board Members will conduct a confidential review of all applications received by the deadline. Upon completion of the review, the committee will notify the applicants of their decision. In order for an FA application to be considered, each applicant must:

- 1) Complete this application in full including listing how you can assist the club, i.e., referee, field marshal, maintenance, etc.
- 2) Attach cash, credit card information, check or money order (payable to CYSL) in the amount of \$250 and attach a proposed payment schedule for the balance (due in full by November 1, 2011).
- 3) Sign the 2011-2012 Code of Conduct, agreeing to abide by the rules of the club.

This program does not cover additional fees a team may incur for tournament participation.
